ARTS AND CRAFTS INFORMATION

JURIED SHOW

GROUNDS: Held in downtown Bandera on the Courthouse lawn.

ELIGIBILITY: Open to individual artists and craftsmen presenting their original works. No manufactured, imported or resale items will be allowed in the Arts and Craft area – only original works and prints by exhibiting artists. Demonstrating your art or craft, while not required, will be a consideration when booths are being assigned. To maintain the quality and balance of the Arts and Crafts shown, this will be a juried show. Bandera Community Foundation, Inc. reserves the right to reject any display that is not in keeping with the examples submitted to jury.

ABOUT THE JURY: A jury of Artists and Craftsmen is selected to judge the pictures and slides presented for consideration for our show. Be sure you send clear pictures that compliment your work, or you may send a sample of your work to be judged.

REGISTRATION: The registration fee is \$130 per space for the two-day show. There will be no price limit on your items sold and no commission will be taken. All registration forms must be accompanied by four slides, or photographs (returned with S.A.S.E. only), and a check or money order payable to Bandera Community Foundation. **Your check will not be cashed until you have been accepted into the show. Deadline for application is August 13, 2010.**

SPACES: Open spaces *only* are provided and are 10'x10'. You provide your own canopy. If you plan to use a canopy, tent, or umbrella, please specify and give dimensions. There are a limited number of spaces available. Electricity is available on a strictly limited basis at an additional charge of \$10 per space, only to those *demonstrating* an art or craft. Contact the Event Coordinator for additional information.

NOTIFICATION OF ACCEPTANCE: Artists will be notified of their acceptance no later than August 20, 2010. You will receive an information packet no later than August 27, 2010. *There will be no refunds after August 27, 2010 and no refunds should bad weather occur.*
