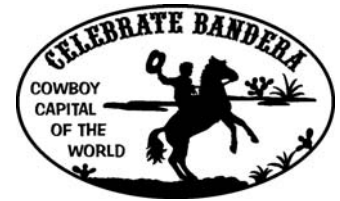




5th Annual INTER-TRIBAL POW WOW

CIRCLE OF LIFE POWWOW ARTS AND CRAFT INFORMATION

GROUNDS: Held AT Mansfield Park, 2886 State Hwy 16 North, Bandera, Texas 78003.

ELIGIBILITY: Open to individual vendors, artists, and craftsmen presenting Native American Indian arts and crafts. Demonstrating your art or craft, while not required, will be a consideration when booths are being assigned. To maintain the quality and variety of the Arts and Crafts shown, you will be invited to participate after your application has been reviewed and accepted. “Circle of Life” powwow charman and Bandera Community Foundation, Inc. reserve the right to reject any display that is not in keeping with the examples submitted as representing your merchandise. Vendor applications must be accompanied with photographs of your merchandise and products. Vendors who have either a Certificate of Degree of Indian Blood (CDIB) or a membership card issued by the federal/state government establishing their membership in a specific Native American Indian Nation may display a sign designating them as a “Native American Indian Vendor”.

REGISTRATION: The registration fee is \$150 per 10’x10’ space or \$200 for a 10’x20’ space for the three-day show. There will be no price limit on your items sold, and no commission will be taken. All registration forms must be submitted no later than August 1, 2009, accompanied by a check or money order payable to: Bandera Community Foundation. Your check will not be cashed until you have been accepted into the show.

SPACES: Open spaces are provided and will be 10’x10’ or 10’x20’. You provide your own canopy. There will be a limited number of spaces available.

NOTIFICATION OF ACCEPTANCE: Vendors will be notified of their acceptance no later than August 21, 2009. *There will be no refunds after August 21, 2009 and no refunds should bad weather occur.*
